The parade travels slowly around 6 blocks near the school, the same blocks traversed regularly by classes from Stonewall Elementary.

Assembly is in front of Stonewall Elementary School. Costumes are encouraged – we especially love to see Red, White, and Blue on kids, adults, friendly dogs, and all manner of nonmotorized vehicles (bikes, wagons, wheelchairs, soap box derby carts, etc.). Small prizes are awarded, and refreshments will be provided afterward for the kids. # **REPORT ON THE SCA ANNUAL BUSINESS MEETING**

The Stonewall Community Association annual business meeting was held on March 26 with Association President Caryl Pfeiffer conducting the meeting in the library of the Stonewall Elementary School. The meeting was well attended, with about 75-80 residents, bringing favorable comments from several of the speakers.

Councilwoman Jennifer Mossotti reported the following road resurfacing in her district for 2018: Beth Lane, Buckingham Way, Keithshire Way, and Wellington Way. Road funds are divided each year among the councilpersons. Each of them then determines where the funds should be spent in their district. Jennifer also mentioned the new cable company, Metronet, which is installing cable lines by sector to provide service to Lexington as an alternative to Spectrum.

We met new Police Chief Weathers, who greeted us and recommended that the best way to cut down vandalism in the community was to greet strangers we see walking or acting suspiciously in our area. He feels strongly that persons who plan mischief don't want to be noticed, and greeting them discourages further action.

Parks representative Michelle Kosieniak reviewed some modifications in Wellington Park, including the installation of a fancy port-a-potty. Victoria Meyer followed this by announcing the installation of the Katsina statue in the park's Women's Garden with a gala celebration on Mother's Day May 13.

David O'Neill, Property Valuation Administrator, alerted us to the revaluation of Stonewall this year and the likely increases in property taxes as a result. He described the appeals process and encouraged home owners to take advantage of it if they feel their assessment is unfair. They have 13 days to appeal. After that the assessment is locked in.

In the absence of the expected speaker, Caryl Pfeiffer reported that Real ID KY drivers licenses meeting the Federal requirements for use in airline travel would be issued in 2018.

Annual Meeting (continued)

Members elected to the Association's executive board included incumbents Trish Henson and Wayne Starnes as well as new members George Alspaugh and John Taormina. Retiring board members Mary Kay Gumberts and Don Starsinic were thanked for their service over many years.

#### **OPENINGS FOR STONEWALL BOARD MEMBERS**

The Stonewall Community Association has openings on its board of directors, including two board members and the association's vice-president. Membership on the board includes four officers serving two-year terms plus a maximum of 15 resident members, each elected for a three-year term. The board meets 6 times a year to deal with issues related to our neighborhood. #### WE NEED HELP ON OUR NEWSLETTER

With the retirement of Don Starsinic from the Stonewall Board after 21 years of service we need someone to replace him on the newsletter team. Don has agreed to continue on the team through the end of 2018, and he can train a replacement during the period. As it now stands, there are three contributors on the team. When it's time to prepare the next newsletter, Don draws up a list of possible topics for articles and circulates it to Janet Cabaniss and President Caryl Pfeiffer, asking them to choose their topics to write articles or to suggest additional topics and agree on a timetable for completion of the newsletter. When articles are written by the three of them and merged, Janet edits and formats the articles to fit the space of the newsletter, we review it, make any corrections necessary, and send it to the printer.

The printed copies are taken to a mailing company, where they are labeled and sent to the post office bulk mail center for distribution. The whole operation takes about a week. The newsletter, which is issued four times a year, has been circulated to Stonewall residents since 2000. We do not want to lose it. #### **ELECTION TIME**

In case you haven't noticed, we are in the middle of hotly contested primary election races for mayor and for the 6<sup>th</sup> congressional district seat. Election date is Tuesday May 22 from 6 a.m. to 6 p.m. If you have not registered or have moved since the 2016 elections, visit the Fayette County Clerk's office, Main Street downtown now and register at your current address. If you were registered on December 31 of last year as a Democrat or Republican, you can vote for any candidates in the party. All registered voters can vote for nonpartisan elections such as mayor or any contested county council seat serving their area.

In local nonpartisan elections, Stonewall voters can vote for one candidate for mayor and 3 candidates for at-large council members. #### 1400 HIGBEE MILL ROAD MULCH CENTER

You may have noticed some activity on this site. The developer had been issued a permit for the placement of fill (less than one acre) within the 100-year floodplain of South Elkhorn Creek. Neighbors in Higbee Woods started an investigation of the "fill" area and involved Stonewall residents in the activity. It was determined that the developer had filled an area greater than one acre (1.3 acres) and that they had filled in the floodway (a portion of the floodplain in which no fill can be placed). These results were presented to the LFUCG and they asked the developer to re-survey the fill area and they found that indeed the developer was in violation of the conditions of their original fill permit. The LFUCG gave the developer a one-time permission to remove the fill from the floodway. Before any additional activity can take place at the site, the developer must apply for a new permit based on a final development plan.

#### **STONEWALL PARK UPDATE**

Liz Pattengill reports that the Stonewall butterfly garden was hit by the extreme cold earlier this year, and some plants were lost. The garden has been weeded and watered. Parsley, mallow, and larkspur have been added. The butterfly weed and swamp milk weed for monarchs are poking through the ground. Next is direct sowing of zinnias and coleus. Mulch will be put down about the end of May. Robert Blankenship indicates that removal of invasive plants will continue this spring. Call him if you can help (619-0115).

#### **COLLECTION SCHEDULE**

The city's FREE collection schedule for various recyclables and waste items for upcoming months is as follows:

Bulk trash collection will occur on July 14 and October 13. Fayette County residents free trash disposal days for non-hazardous household waste are held from 6 a.m. to 1 p.m. at the Bluegrass Regional Transfer Station, 1505 Old Frankfort Pike. One pick-up truck load of household waste including bulky items, such as mattresses, furniture, and up to four tires off the rim, will be accepted at this event.

Free paper shredding is available on May 19 from 9 a.m. to 2 p.m. Bring up to five boxes or bags of dry paper items to be shredded on the spot to 1631 Old Frankfort Pike. Safely dispose of sensitive materials in an environmentally friendly way. Provided by Shred-it, a division of Stericycle. Participants are also invited to bring non-perishable food for donation to God's Pantry.

If you have large quantities of nonhazardous wastes to be disposed of, consider LFUCG's Loan-a-Box program. You can have a container delivered to and hauled away from your residence. Box dimensions are 10' L x 6' W x 4' H. The Loan-a-Box program runs year-round and is scheduled on a first come, first served basis. Fayette County residents and nonprofits with city waste collection service are charged a \$75 fee; non-city-collection residents pay \$180. Call LexCall at 311 or for more information or to reserve a box.
