ANNUAL BUSINESS MEETING, MONDAY MARCH 18

The Stonewall Community Association's annual business meeting is scheduled for Monday March 18 from 7 to 9 p.m. in the Stonewall Elementary School library. We will hear from Jennifer Mossotti (9th District Council Member) and Amanda Mays Bledsoe (10th District) concerning Council issues. Police and Fire representatives will speak on neighborhood safety and house numbering. A Parks and Recreation representative will address the street tree canopy issue. The city's Planning staff will review the update of Lexington's Comprehensive Plan and the PlaceBuilder program, which is designed to be used for property development plans when a zone change is proposed. In addition, we will cover the results of the election of officers and board members and other business issues. Please plan to be there for the meeting.

Board member nominees Leah Atkinson Brand and Liz Pattengill also have been serving on the board. Of the new board nominees, Ed Brand (Leah's husband) is a retired Fayette County school administrator and now works in guest services at Bluegrass Airport. Kevin Duane, a detective with the Lexington Police Department for 18 years, is now an investigator for Kentucky Alcoholic Beverage Control. He is married to lifelong Stonewall resident Kendall Clark Duane, and they have two children who attend Jessie Clark and Stonewall Schools. They live in her childhood home on Tudor Drive. Aaron Ledbetter, a lifelong Lexingtonian and University of Kentucky graduate, works in accounting at Valvoline. He and his wife Tricia live on Lannette Lane and have two children who attend Stonewall School.

CHRISTMAS CAROLING REPORT

Stonewall's 4th annual Christmas caroling event took place last year on Saturday evening December 8. Families and neighbors gathered around the decorated blue spruce tree on a crisp evening to sing carols led by Lexington Singers and Stonewall residents Leah Atkinson Brand and Ed Brand. This year the association produced handouts with the words of the songs, which was very helpful, especially when we got deeper into the verses. In the November newsletter the question was posed to see if homeowners on Cindy Blair or Keithshire would like to have carolers come to their home and if carolers were interested in going from house to house. The response was not enough to have us change the event. We are always open to variations on this event and any of our events. HIGBEE MILL ROAD ACTIVITY

The proposed mulch center at 1400 Higbee Mill Road requires a conditional use permit before the developer can restart any work on the property. Since the developer has yet to apply to the Board of Adjustment for approval, no construction activity can occur. Construction of the day care center at 1580 Higbee Mill Road appears to be on hold. In October of last year, the developer told the community that they would be starting on the construction of a new bridge over South Elkhorn Creek, on November 1, 2018. No activity has occurred to replace the existing bridge.

STREET TREES COST-SHARING PROGRAM

Street trees are any trees located in the public right-of-way between the street and sidewalk. They play a vital role in making Lexington a great place to live. In addition to their beauty, street trees add value to properties and save taxpayers money.

Homeowners are required to maintain street trees in front of their homes. However, they can qualify to receive matching funds for tree removal, stump grinding, and new tree installation by submitting two written estimates by qualified vendors. Lexington offers matching funds to homeowners within the Urban Services Boundary who need to remove and replace street trees. The cost-share ratio is 50 percent. The program is conducted on a first-come, first-served basis, as long as matching funds are available. SOUTH ELKHORN CREEK MEETING

From time to time, this newsletter has mentioned Neighbors United for South Elkhorn Creek (NUSEC), an organization whose main interest is protection of South Elkhorn Creek. The South Elkhorn is one of nine watersheds in Lexington (and fortunately rated as the most pristine); the creek in Stonewall Park is a tributary and it runs also along Higbee Mill Road, where we have followed development close to it for many years. Watershed protection is important for public health and of keen interest to the U.S. Environmental Protection Agency, among other places. On Monday April 8, 6:30 p.m., at South Elkhorn Christian Church, NUSEC will offer a program with watershed group speakers to report on creek status, with the hope of stimulating interest in what can be done to ensure and enhance the safety and beauty of the creek. INCOME TAX TIME

If you haven't filed your 2018 income tax returns yet and need help working your way through all the many federal and state changes and forms used, you can get assistance. AARP's Tax Aide program has helpers at each of the Lexington Public Library branches and at the Lexington Senior Center. They will work up simple returns for you or give you advice on problems and interpretations. Days and times vary by location, first-come, first-served, except at the Senior Center, where appointments can be made (859-278-6072). The nearby Beaumont Library has hours Monday and Friday from 9:30 a.m. to 1:00 p.m. The library branches have stocked the federal 1040 form packet and instructions booklet. You can also go online to the IRS (*irs.gov*) and the Kentucky Department of Revenue (*revenue.ky.gov*) for needed forms and for information. Deadline for filing is April 15.

COLLECTION EVENTS

- lexingtonky.gov\household-hazardous-waste for definitions of eligible wastes, where to take wastes not accepted at this event, and other details. This event may or may not be repeated in 2019, so if you have accumulated such materials, the April event offers a good opportunity to dispose of them.
- LFUCG's spring paper shred event will be on Saturday April 27, 9 a.m. to 2 p.m., at same location as above. Fayette County residents have many opportunities at this event. You may bring up to five boxes or bags of material to be shredded on site at no cost. No wet material will be accepted. This event allows Lexington residents to dispose of their sensitive materials safely in an environmentally-friendly way. Paper-shred participants are also invited to bring nonperishable food for donation to God's Pantry. Currently, the most-needed items include soups, canned fruits and shelfstable proteins. Please do not bring items in glass packaging. And last, the paper-shred event will allow you to bring unneeded campaign yard signs. UPDATE ON STONEWALL COMMONS CHANGES
